Specific Hazards Arising from the Chemical

Reacts with most metals (especially dilute concentrations): Hydrogen gas release (EXTREMELY FLAMMABLE, EXPLOSIVE). Special Fire-Fighting Equipment Procedures

Evacuate personnel to a safe area. Keep personnel removed and upwind of fire. Generates heat upon addition of water, with possibility of spattering. Wear full protective clothing. Runoff from fire control may cause pollution. Neutralize run-off with sodium bicarbonate or soda ash to prevent corrosion of metals and formation of hydrogen gas.

Personal Precautions, Protective Equipment and Emergency Procedures

Soak up small spills with dry sand or diatomaceous earth. Contain large spills and cautiously dilute and neutralize with lime or soda ash. Caution should be exercised regarding personnel safety and exposure to the released product.
